The Committee recognizes that, given the limited time frame for conversation, it is not possible to offer a full quantification of adequate levels of investment. Further study and conversation are required, and the Class I railroad staff can be closely involved in those meetings. We would recommend that the approach and focus for rail safety be organized into three areas:

Education: this includes school curriculum, drivers' education, drivers' license renewal, signage, and marketing. Education is a lower cost and long-term approach to increasing awareness of rail, pedestrian and vehicular safety at crossings and in high traffic areas.

Engineering: we recommend identifying priority projects across the state based on data, developing a budget for those projects, and funding those projects in priority order. Engineering is a significant investment but is the only way to truly affect public safety.

Enforcement: this includes increasing penalties and increasing funding for staffing at the local law enforcement level. Enforcement in all areas is simply not possible given resources and funding.
