

Transportation Rule 6020 Annual Report 2025

(CY 2025 - 2020)

This report, as required by 4 *Code of Colorado Regulations* (CCR) 723-6-6020 (Rule 6020), is submitted to the Public Utilities Commission and to the Director of the Commission and posted on the Public Utilities Commission (PUC or Commission) website. Each section represents a separate line item of the report tied to the rule requirement. Report statistics are by Calendar Year (CY). The reason for CY reporting is related to rule 6020 (b) and (c) as derived from statistics reported by all Common Carriers (taxis, shuttles, etc.) in their annual reports filed with the Commission.

Important definitions to remember while reading this report include:

"Certificate of Public Convenience and Necessity", "Certificate", or "CPCN" means the Authority issued to a Common Carrier declaring that the present or future public convenience and necessity requires or will require the stated operation.

"Common Carrier" is a public utility as defined in § 40-1-102, C.R.S., and includes the obligation to indiscriminately accept and carry Passengers for Compensation. Common Carrier includes every Person directly or indirectly affording a means of transportation, or any service or facility in connection therewith, within this state, by Motor Vehicle; except that the term does not include a:

- Contract Carrier as defined by § 40-10.1-101(6), C.R.S.;
- Motor Carrier that provides transportation not subject to regulation pursuant to § 40-10.1-105,
 C.R.S.;
- Limited Regulation Carrier defined by § 40-10.1-301, C.R.S.;
- Large-Market Taxicab Service defined by § 40-10.1-101(9.5) C.R.S.; or
- Transportation Network Company defined under § 40-10.1-602, C.R.S.

"Contract Carrier" means every Person, who, by special contract, directly or indirectly affords a means of Passenger transportation over any public highway of this state; except that the term does not include a:

- Common Carrier defined in § 40-1-102, C.R.S.;
- Limited Regulation Carrier defined in § 40-10.1-301, C.R.S.;
- Transportation Network Company defined in § 40-10.1-602, C.R.S.; or
- Large-Market Taxicab Service defined in § 40-10.1-101(9.5), C.R.S.

"Limited Regulation Carrier" means a Person who provides service by Charter Bus, Children's Activity Bus, Fire Crew Transport, Luxury Limousine, Medicaid Client Transport, or Off-Road Scenic Charter as those terms are defined in § 40-10.1-301, C.R.S. and rule 6301.

"Permit" means the Permit issued to:

- Contract Carrier pursuant to part 2 of Article 10.1 of Title 40, C.R.S.;
- Limited Regulation Carrier pursuant to part 3 of Article 10.1 of Title 40, C.R.S.;
- Towing Carrier pursuant to part 4 of Article 10.1 of Title 40, C.R.S.;
- Household Goods Mover pursuant to part 5 of Article 10.1 of Title 40, C.R.S.;

- Transportation Network Company pursuant to part 6 of Article 10.1 of Title 40, C.R.S.;
- Large-Market Taxicab Service carrier pursuant to part 7 of Article 10.1 of Title 40, C.R.S.;
- Hazardous Materials Carrier pursuant to Article 20 of Title 42, C.R.S.²; or
- Nuclear Materials Carrier pursuant to Article 20 of Title 42, C.R.S.³

6020 - Report by Commission Staff

Commission Rule 6020 requires that at least once every twelve months, or more frequently if requested by the Commission, PUC staff shall provide a report to the Commissioners and to the Director of the Commission on the financial results (for Fully Regulated Intrastate Carriers⁴), the operational performance of Motor Carriers regulated by these rules as well as the enforcement and compliance actions taken by Enforcement Officials. The first report was due July 1, 2019. Rule 6020 includes the following requirements:

- number of existing and new Certificates and Permits (by type) issued in the current year as well as the previous four years by Type of Service and geographical area;
- (b) total amount of revenue as reported on the Annual Report for the current year and the previous four years for each Common Carrier as well as revenue in the main geographic areas of the state;
- (c) number of trips to Denver International Airport and revenue generated for the current year and each of the last four years for each of the Common Carriers or Contract Carriers or Large Market Taxicab Service providers;
- (d) total number of Motor Vehicle Identification Stamps issued for the current year and for each of the previous four years as well as the amount of annual revenue generated from the stamps;
- (e) the total number of UCR Plan⁵ registrations each year as well as the previous four years;
- (f) number of Authorities suspended, revoked, or abandoned in the current year and each of the previous four years and a summary of the reasons for such status;
- (g) number of Permits (excluding Contract Carrier permits) expired, canceled, or revoked in the current year and each of the previous four years;
- (h) number of vehicle inspections conducted by Enforcement Officials in the current year and each of the previous four years by type (vehicles 10,000 pounds or less and 15 Passenger or less and Commercial Vehicles 10,001 pounds or more and 16 Passengers or more) and a summary of the types of deficiencies noted;
- (i) safety and compliance reviews for the current year and each of the past four years; investigations opened and closed;
- (j) number of CPANs issued (by type) and the amount collected for the current year and each of the previous four years;

- (k) refunds to customers for current year and each of the past four years;
- (I) violation warnings issued for current year and each of the past four years;
- (m) recommendations as to what if any changes should be made to the current rules of the Commission; and
- (n) recommendations as to the priority for the type of enforcement actions for the next year.
- (o) The report shall be provided to each of the Commissioners and the Director and shall be posted on the website of the Commission.



(m) recommendations as to what if any changes should be made to the current rules of the Commission.

It is anticipated that there will be several Notice of Proposed Rulemaking (NOPR) proceedings that will need to be initiated over the course of the next year, including those required by recently passed legislation.

Recently, several NOPRs were concluded and new rules were adopted in 24R-0382TO and 24R-0431TR, respectively. In 24R-0382TO, new towing rules were implemented, effective April 14, 2025, pursuant to House Bill (HB) 24-1051. In 24R-0431TR, new booting/immobilization rules were implemented, effective June 14, 2025, which addressed issues that had been identified since the PUC started regulating this industry back in 2019. In addition, another rulemaking (24R-0448TR) was initiated, which addressed rates for Large-Market Taxicab Service (LMT) carriers, but the rulemaking was closed without any new/updated rules being adopted.

During the 2025 Legislative Session, HB25-1117 and HB25-1291 were passed. HB25-1117 largely increased consumer protections in the booting/immobilization industry, which included many of the same changes seen recently in the towing industry, pursuant to HB22-1314 and HB24-1051. Despite the recently concluded rulemaking for this industry, another NOPR will be required to properly implement all the provisions of HB25-1117. Staff also anticipates a new rulemaking applicable to the Transportation Network Company (TNC) industry, as a result of legislative discussions from the 2025 Legislative Session.

Transportation Staff also intends to initiate another substantial rulemaking, addressing numerous issues within current transportation rules, most notably related to passenger transportation operations. Ideally, this rulemaking will result in simplified requirements and language, which will benefit Transportation Staff, the transportation industry, and the public. It is believed that such modifications can be incorporated, while retaining the primary safety features captured by current rules. Specific areas of interest include various reporting requirements (*i.e.*, insurance, medical certification, vehicle inspections, etc.), vehicle fees, tariffs, hours of service requirements, credit card surcharges, and the vehicle registry. This rulemaking would also capture some recent changes in statutory language, based on the passage of several legislative bills.

(n) recommendations as to the priority for the type of enforcement actions for the next year.

Transportation Staff recommends the continuation of its efforts to identify and address illegally operating transportation carriers (*i.e.*, those without authorities or permits and no insurance on file with the Commission). This remains a high priority and recent enforcement activities, such as those occurring at Denver International Airport (DIA) and Red Rocks Amphitheatre (Red Rocks), have shown progress on this front. These additional, and more frequently scheduled, enforcement operations at DIA and Red Rocks have also focused on the passenger carrying industry, which includes TNCs.

The Investigations and Compliance Unit has launched additional efforts related to field operations-including trips to outlying areas and rural communities—in order to address safety and enforcement concerns. This has included trips to various areas along the Western Slope, Aspen, Durango, and Steamboat Springs. Such attention has continued to promote relationships with other law enforcement agencies in and around these communities. Also, each member of the Investigations team has been assigned an airport operation within the state, to provide additional enforcement consideration and address any issues raised by airport authorities and local stakeholders. Overall, most trends in enforcement have been going up since 2022, which can be credited to these goals, strategies, and initiatives. The tenacity and detailed approach taken by the Investigations staff is also worthy of recognition, both in targeting problematic actors and building relationships with stakeholders and other government agencies to develop more collaborative approaches to troublesome issues.

Ever since the passing of House Bill (HB) 22-1314, there have been significant spikes in new investigations, mostly related to the towing industry, which began shortly after the new statutes became effective in August 2022. However, recent figures suggest that these numbers are trending down of late, which has allowed for more time to clear out the backlog of cases. A recently implemented policy on case closure timelines has also assisted with these efforts.

Despite the still high level of case volume, the Investigations and Compliance Unit endeavors to make time to participate in a significant number of outreach efforts, as it pertains to both transportation carriers and various law enforcement agencies. This includes trainings provided to groups, agencies, and associations, such as Towing and Recovery Professionals of Colorado (TRPC), the Colorado Limousine Association (CLA), and the Colorado Clerk's Association (CCA). In addition, the team is focusing on collaboration with the Colorado State Patrol (CSP) to assist with the education and training of rotational towing carriers and to help them navigate various situations and problem-solving when it comes to illegal and/or challenging operations. Furthermore, the Investigations team is working with the Colorado Department of Transportation (CDOT) to address problematic towing carriers operating along the I-70 Corridor, who are often chronic offenders not adhering to state laws and Commission rules. The continuation of these outreach initiatives will result in improved relations and better collaboration with these stakeholders.

While towing concerns still occupies much time and resources, the Investigations team intends to expand its focus in the passenger carrying industry in the coming year, including scheduling and conducting Safety & Compliance Reviews (SCRs).
